- Internal elections for positions (e.g. Events Director, Sponsorship Director) within the 2009 FMAA Executive Committee will occur on **Thursday 9 October at 6.15pm** (Venue: Room 106, Colin Clark Building).
- Only the newly elected 2009 FMAA Executive Committee members and outgoing 2008 Executive Committee members will be eligible to vote for positions within the 2009 FMAA Executive Committee at the internal elections.
